<u>1</u>st <u>VP, Membership</u> – Responsible for PTSA membership drive(s) and organizes membership events. Performs other duties as assigned by the president or the association.

<u>2nd VP, Ways & Means</u> – Responsible for PTSA fundraising and the development of new fundraising opportunities. Performs other duties as assigned by the president or the association.

<u>3rd VP, Business Partners</u> – Responsible for securing business partners from the local community. Authorized to sign on bank accounts. Performs other duties as assigned by the president or the association.

<u>Corresponding Secretary</u> – Prepares all written communication on behalf of the PTSA. Performs other duties as assigned by the president or the association.

<u>Recording Secretary</u> – Responsible for recording minutes of the association and keeping accurate records of all official work of the association. Authorized to sign on bank accounts. Performs other duties as assigned by the president or the association.

<u>Treasurer</u> – Responsible for the funds of the association and maintaining and keeping accurate books and records. Chairs the Budget Committee. Authorized to sign on bank accounts. Presents financial reports, both written and verbal, at all meetings. Performs other duties as assigned by the president or the association.
